For Productive Hawker Centre such as Blk 163 Bukit Merah Central, Market Street Hawker Centre, Margaret Drive Hawker Centre and Marsiling Mall Hawker Centre, stallholders are to subscribe to the centralised dishwashing services and to use only common crockery and cutlery provided by the Service Provider. Stallholders are not to use or provide patrons with disposable crockery and cutlery for dine-in.
