- Table Cleaning Fee. The range of monthly table cleaning fee indicated serves as a reference for a typical cooked food stall in the respective hawker centre, to assist tenderers in cost estimation only. The actual fee may be lower or higher depending on the table-cleaning contractor for the respective hawker centres.
- Service & Conservancy Charge (S&CC). The range of monthly S&CC indicated serves as a reference to tenderers for cost estimation purpose only. For the actual S&CC, one should refer to the respective Town Council or National Environment Agency (NEA) for the centres under its charge.

Note 1:

- a. The sale of solely alcohol is not allowed at drink stalls.
- b. Stallholders shall not provide disposable crockery and cutlery for use by dine-in patrons.
- c. Please note that the allowable electrical load differs in each market and food centre. Tenderers are advised to check the approved electrical loading stated and ensure that the electrical load meets the operational requirements before tendering. Successful tenderers are to accept and comply with the existing approved electrical loading.
- d. The Service & Conservancy Charge is higher for a stall that is larger in size at **Blk 4A Jalan Batu and Blk 32 New Market Road Food Centre**.
- e. Please note that stall **#01-07 at Blk 117 Aljunied Avenue 2** is not equipped with an exhaust hood. If stallholder plans to carry out cooking activities that generates fumes, oil and heat, the stallholder is required to submit Additions & Alterations (A&A) application for the installation of the exhaust hood **at his own expense (subject to NEA's requirement)**.
- f. Please note that stalls **#01-64, #01-89 at Beo Crescent Market, #02-23, #02-26 at Blk 163 Bukit Merah Central, #01-35, #01-56 at Blk 79 Circuit Road, #01-75, #01-79 and #01-91 at Blk 79A Circuit Road, #01-07 at Blk 20 Ghim Moh Road, #01-12, #01-18 and #01-21 at Blk 84 Marine Parade Central** are not equipped with exhaust hood and Electrostatic Air Cleaner (EAC). - g. Please note that stalls **#01-012 at Berseh Food Centre, #01-53 at Blk 115 Bukit Merah View, and #01-17 at Blk 14 Haig Road** are located between Halal Cooked Food stalls. The stallholder is to exercise sensitivity in the choice of food type. NEA will determine the sensitivity of the food type before the allocation of stall.
- h. Please note that a specialised Fire Suppression System is installed in stall **#01-18 at Blk 1 Jalan Kukoh**. Prior approval has to be obtained from NEA before any alteration/modification can be carried out to the Fire Suppression System.
- i. For **Productive Hawker Centre** such as **Blk 16 Bedok South Road, Blk 163 Bukit Merah Central, Blk 84 Marine Parade Central and Blk 6 Tanjong Pagar Plaza**, stallholders are to subscribe to centralised dishwashing services and to use only common crockery and cutlery provided by the Service Provider. Stallholders are not to use or provide patrons with disposable crockery and cutlery for dine-in.

Details of Tender

- Eligibility Criteria: Tenderers must be an individual Singapore Citizen or Permanent Resident and not less than 21 years of age. Tenderers must not be debarred from holding a Singapore Food Agency (SFA) stall licence. All former registered assistants and/or nominees who have been de-registered by the National Environment Agency shall not be eligible to tender. All persons who are debarred by the Government or Statutory Boards from participating in tenders for all lines of business shall also not be eligible to tender. Tenderers must not be renting or a joint operator of two cooked food stalls in markets/hawker centres managed by NEA.
- Undischarged bankrupts who became bankrupt due to unemployment/retrenchment/ill health/failure in previous business venture/liabilities due to guarantees through no fault of his/her own, but are now healthy and ready to operate a small business may tender for a stall. Each undischarged bankrupt is only allowed to rent a maximum of one (1) market/cooked food stall. In the event that an undischarged bankrupt submits bids for more than one (1) market/cooked food stall, and emerges as the highest bidder for more than one (1) market/cooked food stall, NEA reserves the right (but shall not be obliged) to award up to one (1) market/cooked food stall to him. The tender award shall be at the sole discretion of NEA.
- Tenderers are advised to consider the overall overhead costs for their business carefully before submitting tender bids and tender at a rent which is sustainable. Tenderers should conduct an assessment of the location and business volume of the stall. Tenderers may wish to refer to NEA website for the list of successful tender bids in the past 12 months. This information can serve as a reference for tenderers as they decide how much they should bid for a stall in a particular hawker centre. Tenderers shall read carefully the **Terms and Conditions of Tender (Ver 1: Aug 2026)** as set out at **go.gov.sg/tendernotice** which will form part of the terms and conditions of the Agreement. By proceeding with the Tender process, tenderers acknowledge that they understand and agree to be bound by the Terms and Conditions of Tender.
- Tender bids shall be submitted through NEA's electronic tendering system (E-Tender) using FormSG. **Tenderers shall refer to NEA website at go.gov.sg/tendernotice for NEA's E-Tender system.** Tenderers will require SingPass to log into the E-Tender FormSG.
- When submitting the Form of Tender via FormSG, the tendered rent shall not include the Service and Conservancy Charges (S&CC), refuse removal fee, licence fees and the Goods and Services Tax (GST). The NEA reserves the right to revise the S&CC from time to time. The successful tenderer shall bear the GST to be levied on the tendered rent and S&CC. Tenderers shall submit their tendered rent offer to the nearest cent. In the event that the tenderer submits its tendered rent offer with a price containing more than 2 decimal places, the tendered rent shall be rounded to the nearest 2nd decimal place. For example, if the tendered rent offered is \$100.336, the final tendered rent used for evaluation shall be rounded to the nearest 2nd decimal place, i.e. \$100.34.
- When submitting the Form of Tender via FormSG, tenderers are required to pay a **tender deposit of \$500** for each stall tendered for before the tender closing date and time. Payment of the tender deposit can be made by debit card, credit card or PayNow.
- Tenderers are **not to** discuss the bid prices or consult anyone else regarding the tender details (e.g. bid prices, factors used to calculate bid prices, the decision to tender). If tenderers are unable to fill in the Form of Tender by themselves and need to seek assistance from another person, tenderers are to ensure that they do not discuss the bid prices with that or any other person or consult that or any other person regarding the tender details. **Tenderers shall read and comply with the requirements as set in the Terms and Conditions – Anti-Collusion**

- The NEA reserves the right to withdraw any of the units from the tender exercise at any time, before or after the tender closing date, without prior notice given.
- The 5 highest Tender bids may be released within 2 weeks after Tender closing date. When released, the 5 highest Tender bids will be posted on NEA website and displayed on the notice board at our One-Stop Information and Service Centre (OSISC) located at 480 Lorong 6 Toa Payoh, #26-01, HDB Hub (East Wing), Singapore 310480. Tenderers who do not meet the following criteria such as less than 21 years old, non-Singapore Citizen/Permanent Resident or submitted more than 1 bid for the same stall, will be indicated as 'Disqualified' in the 5 highest Tender bids. The Tender evaluation and approval may take about 5 to 7 weeks, depending on the Tender bids and complexity of the evaluation process. The estimated timelines herein serve as guide and are not binding on NEA.
- **The NEA reserves the right not to accept the highest bid or any bid at all and the decision of the NEA shall be final.**
- Once the tender results are finalised, the tender results/bids will be displayed at the NEA website and OSISC Notice Board. The NEA does not place tenderers as reserves. Fresh tenders will be called if the successful tenderers do not take up the stalls.
- As a guide and subject to confirmation by NEA, the Agreement shall commence on the 1st of the following month after the release of the Tender results [i.e. for the Aug 2026 Tender exercise which closes on 26 Aug 2026, tender results shall be released in about 5 to 7 weeks, and the Agreement shall commence on 1 Nov 2026 (always the 1st of the month)].
- The Agreement with any successful tenderer for a cooked food stall or market stall shall be for a period of **thirty-six (36) months**. Subsequent renewals may be refused or granted on such terms and conditions to be determined by the NEA. Where an Agreement has been renewed, the rental may be revised as determined by the NEA. For successful tendered rent that are below the Assessed Market Rent (AMR), the rent at renewal is determined by NEA and NEA may moderate the rental increase at each tenancy term to reach the AMR. For successful tendered rent that are higher than AMR, the NEA will stagger the downward adjustment of tendered stall rentals. At the point of first tenancy renewal, the rental for such stalls will be adjusted downwards by 50% of the difference between their tendered rent and AMR. At the next or subsequent tenancy terms, the NEA will adjust the stall rentals to the AMR.

For example, if the tendered rent is \$5,000 in the first tenancy term (Year 1 to 3) and AMR is \$1,000, the renewed rental will be \$3,000 from Year 4 to 6, and the subsequent renewed rental will be at the AMR of \$1,000 from Year 7 to 9.

- After signing the Agreement, stallholders can apply and carry out the Addition and Alteration (A&A) works upon approval. Once the Agreement date has commenced, rental would be collected. No rent-free fitting period will be given to the successful tenderer if more time is required for renovation after the Agreement commences.

- Term of tenancy: 3 years.
- Stallholders are to personally operate and are not allowed to sublet their stalls. All stalls **are let out in its existing state**. The successful applicant must obtain the written approval of NEA before carrying out any Additions & Alterations (A&A) works to the stall. Any reinstatement works expenses will be borne by the applicant (including, but not limited to, the installation of exhaust hood, any electrical installation/extension or rewiring/piping works at the stall). If the stall does not come with an exhaust hood and the successful tenderer plans to carry out cooking activities that generate fumes, oil and heat, the successful tenderer shall submit A&A application for the installation of the exhaust hood at his own expense (subject to NEA's requirements).
- Please note that if the stall does not come with water meter and/or electrical meter and/or gas meter, the successful tenderer shall install the water meter and/or electrical meter and/or gas meter at his own cost and expense.
- If the stall is equipped with Electrostatic Air Cleaner (EAC), stallholder is required to maintain the EAC regularly, i.e at least once every 2 months and ensure that the EAC is in working condition.
- In addition to the payment of the monthly rent, the successful tenderer is required to pay the monthly S&CC, table-cleaning charges (for cooked food stalls only), and SFA stall licence fee (where applicable).
- For cooked food stalls, the successful tenderer and their assistants must submit the SkillsFuture Singapore (SSG) Food Safety Course Certificates at the time of signing the Agreement for the stall. NEA will not issue the SFA stall licence to the successful tenderer to operate the stall if he fails to submit the above document. The tenderer will not be allowed to commence operation of the stall without a food stall licence.
- Please note that during the tenancy period, hawker centres may be affected by **Repairs and Redecoration (R&R)** carried out by NEA or the respective Town Councils. Hawker centres would also be closed for regular **spring-cleaning** (generally on a quarterly) basis. Stallholders may be required to cease business during R&R and spring cleaning.

1	Piece & Sundry Goods	Includes kitchen ware, hardware, textiles, toiletries, clothing, footwear, watches, fashion accessories, costume jewellery, toys, sports accessories. Sale of jewellery, computer games/ videos, handphones and tablets are not allowed. Services such as beauty and photocopying services are also not allowed.
2	Preserved & Dried Goods	Includes salted vegetables/ fish/ eggs, dried prawns, cuttlefish/ mushrooms, onions, garlic, potatoes and provision goods like canned food, cooking oil, sauces, sugar, flour, salt, rice, other condiments, pre-packed titbits (inclusive of biscuits and sweets) and bottled/ canned/ packet drinks (not in chilled form).
3	Pork	Means exclusively pork. Sale of other types of meat together with pork is not allowed.
4	Beef	Means exclusively beef. Sale of other types of meat together with beef is not allowed.
5	Mutton	Means exclusively mutton. Sale of other types of meat together with mutton is not allowed.
6	Poultry	Means exclusively poultry. Sale of other types of meat together with poultry is not allowed.
7	Frozen Goods	Means various types of frozen meat, including the viscera, frozen peas and pre-packed frozen foodstuffs, in a frozen state. Meat in chilled state is not allowed.
8	Frozen Processed Food	Means various types of pre-packed foodstuffs, peas, in a frozen state. Sale of frozen or chilled meat, including the viscera is not allowed.
9	Fresh Seafood	Means fresh fish, squids, prawns, crabs, lobsters and other shellfish. Sale of live frogs and turtles are not allowed.
10	Processed Raw Seafood	Means processed raw seafood products like fish balls, fish cakes and "Yong Tau Foo" items.
11	Whole Fruits	Means all types of fruits in whole. Sale of cut fruits is not allowed.
12	Vegetables	Means all types of vegetables and include roots like lotus roots, sweet potatoes, tapioca, radish and fruits that are used for preparation of meals, like gourds, tomatoes, pumpkin and unripe papayas.
13	Flowers	Means all types of fresh flowers and potted plants.
14	Beancakes & Noodles	Includes bean-cakes, "Mee", "Kway Teow" and "Bee Tai Mak". Sale of bean sprouts and pre-packed vegetarian products are allowed.
15	Eggs	Includes eggs of hens and quails.
16	Assorted Spices	Means all types of assorted spices.
COOKED FOOD STALL		
1	Halal Cooked Food	Sale of cooked food (Halal) only. Sale of non-halal food is not allowed.
2	Indian Cuisine	Sale of cooked food (Indian cuisine) only. Some examples of Indian cuisine include vadai, thosai, roti prata, nasi briyani, putu mayam, masala/ tandoori chicken. Sale of non-Indian cuisine is not allowed.
3	Cooked Food	Sale of any type of cooked food, and hot and cold desserts.
4	Drinks	Sale of hot and cold drinks which include package/ bottled/ dispenser drinks, small food items like cakes and buns, or sale of other cold drinks such as soya beans drinks, grass jelly drinks, sugar-cane juice. The sale of solely alcohol is not allowed at drink stalls.
5	Cut Fruits	Sale of all types of fruits in 'cut' form. Sale of jelly, sugar-cane juice and grinded fruit juice are allowed except bottled/ prepared drinks.
