# LICENSING REQUIREMENTS FOR HYDROFLUOROCARBONS (HFCs) CONTROLLED UNDER THE ENVIRONMENTAL PROTECTION AND MANAGEMENT ACT

With effect from <u>1 Jan 2019</u>, 18 types of HFCs (inclusive of blends/mixtures that contain one or more of these HFCs) will be controlled by the National Environment Agency ("NEA") under the Environmental Protection and Management Act ("EPMA").

#### **Licensing Requirements**

- Companies importing and/or exporting any of the controlled HFCs (inclusive of blends/mixtures that contain one or more of these HFCs) are required to obtain a Hazardous Substances Licence from NEA prior to the import and/or export. The controlled HFCs are listed in **ANNEX A**. Applications can be submitted to NEA online via Licenceone at https://licence1.business.gov.sg.
- In addition to a Hazardous Substances Licence, companies importing the **flammable HFCs** that are jointly controlled by SCDF and NEA are required to obtain Import Licence from SCDF. Companies storing and transporting flammable HFCs above SCDF's exemption quantities are also required to obtain Storage and Transportation Licence from SCDF. The list of HFCs jointly controlled by NEA and SCDF are listed as follows:
  - i. Difluoroethane (HFC-152a)
  - ii. Difluoromethane (HFC-32)
  - iii. Methylfluoride (Fluoromethane) (HFC-41)
  - iv. 1,1,1,3,3-pentafluorobutane (Pentafluorobutane) (HFC-365mfc)
  - v. 1,1,1-Trifluoroethane (HFC-143a)





- With effect from 1 Jan 2019, traders and declaring agents are required to declare in the import and export permit applications for HFCs using the relevant HS Codes and NEA/SCDF Product Codes in the following Annexes:
  - i. Annex A Import and Export<sup>1</sup> Permit Applications for Controlled HFCs
  - ii. **Annex B** Import Permit Application for HFCs Jointly Controlled by NEA and SCDF **above SCDF exemption quantities**
  - iii. **Annex C** Import Permit applications of HFCs Jointly Controlled by NEA and SCDF below SCDF exemption quantities
- 5 For importation of blends/mixtures containing one or more of the 5 jointly controlled HFCs and are categorized under flammables, companies are required to contact SCDF for assessment and advice on the Import, Storage and Transportation Licence.

### <u>TradeNet Declaration involving 1,1-Difluoroethylene (HFC-1132a)</u>

- With effect from 1 Jan 2019, traders and declaring agents are only required to declare for the import of 1,1-difluoroethylene (HFC-1132a) using SCDF product codes only.
