RE: SPRING CLEANING AT 511 KAKI BUKIT MARKET & FOOD CENTRE

Dear Sir.

I am appealing to you for assistance for the coming spring cleaning at 511 Kaki Bukit Market & Food Centre schedule for five days from 24th June to 28th June 2013.

On 26<sup>th</sup> April we had a meeting with AHTC, Mr. Tai and was informed that their contract with the current vendor does not include any cleaning above 2.5 meters above ground and any cleaning above 2.5 meters the additional expenses incurred shall be borne by stall owner/operator.

In the past decade we had cleaning schedule of two minor & major spring cleaning. The minor cleaning usually need a day, the scope of cleaning is the flooring within the food center and surrounding common areas while the major cleaning need five days as the scope include cleaning the celling & cleaning of the celling gutter of debris with no additional cost to us.

We understand that the spring cleaning practice is set by NEA and we fully support it because it ensured a clean environment for the residents and general public who patronize the place. We on our part co-operate with the spring cleaning and stop business for five days without income and reimbursement for our losses; we also foot the bill of erection of tent age to cover our stall from spill during the cleaning process.

The practice set by which agency is irrelevant when the root cause is for the good of residents and that the reason we support it. We also hope that you and AHTC in view of the cause and for the residents will engage a capable contractor to do the job like the former town council had done without incurring further financial hardship on the stall owner/operators.
