### Weekday Walk-In Consultation

## **Background**

- 1. Currently CBPD conducts walk-in consultation sessions for QPs to:
  - a. Clarify and explain to QPs the rationale behind the requirements specified in the codes of practices and regulations;
  - Help QPs to resolve queries from the stipulated environmental codes of practice;
  - c. Assist QPs on their preparation of development control/building plans in accordance to the codes of practices and regulations.

QPs can walk in for consultation anytime from Mondays to Fridays between 9am to 12noon without the need to make prior appointment.

## **New Change**

In our ongoing effort to improve our service to the industry partners, CBPD will be enhancing our walk-in consultation service to provide greater convenience and minimise any unnecessary waiting time. The existing walk-in consultation will be replaced by an electronic appointment booking system.
