

## LODGEMENT SCHEME EXPANSION (MINOR ADDITION & ALTERATION WORKS FOR INDUSTRIAL DEVELOPMENTS)

## CIRCULAR TO PROFESSIONAL INSTITUTIONS

Who should know

Owners, Developers, Architects, Engineers, Contractors and Builders

## Background

Since 2018, the National Environment Agency (NEA) implemented the Lodgement Scheme to streamline the building plan submission process. The scheme currently includes the following scope of works:

- Minor Development Projects (MDP) that do not involve pollution control (PC) and environmental health (EH) matters such as pavilions and linkways;
- b. All landed properties, with the exception of strata titled landed properties with communal facilities and those requiring waivers on Section 9 of the Code of Practice on Environmental Health.

## New Change

2. NEA will be expanding the scheme to include Addition & Alteration (A&A) works for industrial developments. A&A works that <u>do not involve Environmental</u> <u>Health (EH) or Pollution Control (PC) matters</u> will be able to qualify for the lodgement scheme if they meet the following criteria:

- i. No change in industrial activities.
- ii. No increase in refuse output.
- iii. No change in hazardous substances stored/used.
- iv. No roof gutters or design features that may result in water stagnation.
- v. No works involving cooling towers and/or centralised air-conditioning & mechanical (ACMV) systems.
- vi. No provision or replacement of pollution control measures, facilities, or equipment.
- vii. Nuisance buffer requirements can be complied with.

Some examples are provided below:

- Structural works (Pipe support structures, maintenance platform, pipe risers, hatch coaming, cladding, gantry cranes etc.)
- Ancillary facilities such as factory shed

- Internal works such as internal/escape staircases, renewal of flooring, partition works
- Reconfiguration of industrial units without change/expansion in activities

3. The new changes will take effect from **3 Jan 2022.** QPs can visit the following website to make a lodgment plan submission:

Alternatively, QPs may use the QR code attached to make a lodgement plan submission:



When filling up the lodgement scheme application, QPs are required to:

- Provide a brief description of the proposed scope of works.
- Attach necessary supporting plans.
- Declare that no Environmental Health matters are involved.
- Declare that no Pollution Control matters are involved.

4. Upon receiving the completed Lodgement scheme application, our officers will issue a CSC Clearance letter for the proposal within three (3) working days.
