CIRCULAR TO PROFESSIONAL INSTITUTIONS

Who should know

Developers, Architects, Engineers, Contractors and Builders

Dear Sir/Madam.

Approved List of Class 1/Type 1 Integrating Sound Level Meters

This circular is to inform all Qualified Persons (QPs) of the Approved list of Class 1/Type 1 Integrating Sound Level Meters (SLM) that are used for the purpose of carrying out noise assessments.

- 2 Prior to issuance of Temporary Occupation Permit (TOP) or Certificate of Statutory Completion (CSC) clearance, a noise assessment will be required for the following:
 - a) Non-industrial developments that installed new air-conditioning and mechanical ventilation system; and
 - b) New residential and noise-sensitive developments located within 70m from land traffic noise source (e.g. expressway/major arterial road/MRT tracks)
- All noise measurements carried out in the noise assessments shall be recorded using Equivalent Continuous Noise Levels (Leq), which is in accordance with the requirements stipulated in the Technical Guidelines on Boundary Noise Limits For Air Conditioning and Mechanical Ventilation Systems in Non-Industrial Buildings and Technical Guidelines for Land Traffic Noise Impact Assessment. However, we have received reports measured using non-Class 1/Type 1 SLMs and SLMs which lack the function to measure Leq.
- To provide clarity to the industry, and in consultation with industry stakeholders such as Singapore Institute of Architects (SIA), Institute of Engineers Singapore (IES), the Association of Consulting Engineers Singapore (ACES), the Singapore Contractor Association Ltd (SCAL), suppliers of SLM and acoustic specialists, NEA will only accept noise assessment reports which noise measurements are measured using approved SLMs with effect from 1 Oct 2018.
